

# PRIVACY POLICY

Welcome to **Garden Revelry** ("Company", "Website", referred to as "we," "us" or "our"). Your privacy is important to us. To better protect your privacy, we provide this policy explaining our on-line information practices and the choices you can make about the way your information is collected and used by the Website whether a guest or registered user.

When accessing the Website, **Garden Revelry** will learn certain information about you, both automatically and through voluntary actions you may take, during your visit. This policy applies to information we collect on the Website and in email, text, or other electronic messages between you and the Website.

### YOUR CONSENT AND AGREEMENT

Please read this entire policy carefully before using or submitting information to this Website. Whenever you visit the Website, or by clicking to accept the Terms and Conditions when this option is made available to you, you consent to the collection, use, and disclosure of information in accordance with this Privacy Policy. If you do not agree to these terms, you must not access or use this Site.

## INTERPRETATION and DEFINITIONS

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

- Account means a unique account created for You to access our Service or parts of our Service.
- **Affiliate** means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.
- **Business**, for the purpose of CCPA/CPRA, refers to the Company as the legal entity that collects Consumers' personal information and determines the purposes and means of the processing of Consumers' personal information, or on behalf of which such information is collected and that alone, or jointly with others, determines the purposes and means of the processing of consumers' personal information, that does business in the State of California.
- **CCPA** and/or **CPRA** refers to the California Consumer Privacy Act (the "CCPA") as amended by the California Privacy Rights Act of 2020 (the "CPRA").
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Garden Revelry LLC, P.O. Box 15257 Seattle WA 98115-0257.

For the purpose of the GDPR, the Company is the Data Controller.

- **Consumer**, for the purpose of the CCPA/CPRA, means a natural person who is a California resident. A resident, as defined in the law, includes (1) every individual who is in the USA for other than a temporary or transitory purpose, and (2) every individual who is domiciled in the USA who is outside the USA for a temporary or transitory purpose.
- **Cookies** are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.
- Country refers to: Washington, United States

- **Data Controller**, for the purposes of the GDPR (General Data Protection Regulation), refers to the Company as the legal person which alone or jointly with others determines the purposes and means of the processing of Personal Data.
- **Device** means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- **Do Not Track** (DNT) is a concept that has been promoted by US regulatory authorities, in particular the U.S. Federal Trade Commission (FTC), for the Internet industry to develop and implement a mechanism for allowing internet users to control the tracking of their online activities across websites.
- Garden Revelry Website, referred to as "Website, We," "Us" or "Our
- **GDPR** refers to EU General Data Protection Regulation.
- Personal Data is any information that relates to an identified or identifiable individual.

For the purposes of GDPR, Personal Data means any information relating to You such as a name, an identification number, location data, online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity.

For the purposes of the CCPA/CPRA, Personal Data means any information that identifies, relates to, describes or is capable of being associated with, or could reasonably be linked, directly or indirectly, with You.

- Service refers to the Website.
- **Service Provider** means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used. For the purpose of the GDPR, Service Providers are considered Data Processors.
- **Usage Data** refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).
- Website refers to Garden Revelry, accessible from <a href="https://www.gardenrevelry.com/">https://www.gardenrevelry.com/</a>
- You means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

Under GDPR, You can be referred to as the Data Subject or as the User as you are the individual using the Service.

# **AGE RESTRICTIONS**

This Website is not intended for children under the age of 13 although none of the Website content is considered harmful to those under the age of 13. We do not knowingly collect personally identifiable information through this Website from visitors under 13 years of age without the express consent of their parents. If an individual under 13 years of age has provided us with information, a parent or guardian of that child should contact us if they would like the information deleted from our records. "Personal Information" as used in this policy, is information that specifically identifies an individual, including, but not limited to, an individual's name, home address, telephone number, or e-mail address, or credit card information when purchasing courses or workshops. All this information is provided to us by you. Please read **Payment Security Information** for more information on credit card details.

#### DO WE SHARE OR DISCLOSE INFORMATION TO THIRD PARTIES?

We value your privacy. Your Personal Information will not be sold, exchanged, transferred, or given to any other company or third party under any circumstances, except for the following:

- Your Personal Information may be shared with third parties that perform functions on our behalf, such
  as maintaining and operating the Website and its content. We do not allow such third parties to use
  your information for other purposes.
- We may also disclose your Personal Information when legally compelled to do so; when the law requires us to or in order to protect ours or others' rights or enforce our site policies.
- As required by a court or government agency or to respond to a claim by you or a third party; or
- As you have otherwise agreed.

While we protect your Personal Information, please be aware that should you engage in aspects of our Website that make your Personal Information available for viewing by third parties online – for example, by commenting on blog posts, writing on message boards, participating in online chats – such information can potentially be seen, collected and used by others besides us. We cannot be responsible for any unauthorized third-party use of such information and if you decide to access third party sites linked through the Website you do so at your own risk.

#### WHAT INFORMATION DO WE COLLECT?

The Website provides various places for users to provide information. After visiting our Website, Garden Revelry will only contact you via e-mail if you have signed up to receive information, newsletters, purchased a product or left an inquiry with us.

## SUBSCRIBE TO NEWSLETTERS

The Website offers an option to subscribe to our newsletters. Should you choose to subscribe we will collect personal information, such as your name and e-mail address. Any e-mail you receive from the Website will contain the option to "unsubscribe" at the end of every e-mail. You can unsubscribe at any time. Your information is stored on the server that delivers the newsletters for Garden Revelry. This information may only be accessed by those who assist in the list management so that you receive the newsletters

#### **CHALLENGES & CONTESTS**

To enter any challenges, giveaways or contests on the Website, we ask you for your e-mail address and your first and last name. We may at any time request other information in order to verify the entrant's identity, location, or age. In some situations, we need additional information, such as a prize selection choice or some details regarding you or your business. We may also request you post a comment on the Website as a form of entry to the giveaway. Participation in these giveaways or contests is completely voluntary and you therefore have a choice whether or not to disclose this information.

#### **EMAIL**

If you choose to correspond with us through email, we may retain the content of your email messages together with your email address and our responses. We provide the same protections for these electronic communications that we employ in the maintenance of information received online, mail, and telephone. This also applies when you register for our website, sign up through any of our forms using your email address or make a purchase on this site. For further information see the email policies below.

## **EMAIL POLICY**

We are committed to keeping your e-mail address confidential. ## OTHER INFORMATION COLLECTED

The Website also may use web beacons in order to access cookies, to count users who visit the Website or open HTML email messages. As you navigate our Website, we may use automatic data collection technologies including Google Analytics to collect certain information about your equipment, browsing actions and patterns. This will generally include information about your location, traffic patterns through our website, and any communications between your computer and our Website. The information we collect automatically is used for statistical data and will not include personal information. We use this data to improve our Website and offerings.

### **OUR WEBSITE'S USE OF COOKIES**

Cookies are very small text documents that a site or its service provider transfers to your computer's hard drive through your computer's internet browser to store your preferences. - You have the right to request to limit the use or disclosure of certain sensitive personal information We
  collected about You, unless an exception applies. To submit, please see the "Limit the Use or

  - Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when the information's deletion may likely render impossible or seriously impair the research's achievement, if You previously provided informed consent.
  - Enable solely internal uses that are reasonably aligned with consumer expectations based on Your relationship with Us.
  - Comply with a legal obligation.
  - o Make other internal and lawful uses of that information that are compatible with the context in which You provided it.
- You have the right not to be discriminated against for exercising any of Your consumer's rights, including by:
  - Denying goods or services to You
  - o Charging different prices or rates for goods or services, including the use of discounts or other benefits or imposing penalties
  - Providing a different level or quality of goods or services to You
  - $_{\circ}$  Suggesting that You will receive a different price or rate for goods or services or a different level or quality of goods or services
